

Greetings from Germany! I am writing this from Jena, where I am spending six months at the Imre Kertész Kolleg, an institute for the study of 20th century Eastern Europe from a transnational or interdisciplinary perspective. I am very excited to have this opportunity to engage in dialogue with scholars of Eastern Europe from around the world and hear about their work. Although I have only been here a few weeks, I have already heard two excellent presentations at the Kolleg's weekly colloquium: Peter Haslinger (Herder Institute, Marburg) spoke on his research comparing the role of experts in the creation of spatial knowledge in interwar Poland, Hungary and Czechoslovakia and Piotr Oseka (Institute of Political Studies, Polish Academy of Sciences) gave an overview of his work on the private and public lives of career officers in the Polish security service. While extraordinarily different, both presentations pointed to an effort to use

the methods of intellectual and social history to shed new light on questions of national politics or state power.

This week, the Kolleg hosted a conference that addresses a crucial area of new research: the place of Eastern Europe in the wider world. This conference, "Alternative Encounters: The 'Second World' and the 'Global South', 1945-1991," looked at the interactions and exchanges between Eastern Europe and Asia, Africa and Latin America during the era of decolonization. One important theme of many presentations was to consider the countries of the Soviet Bloc as independent actors on the global stage, not merely Soviet proxies. Another theme was the tension between exchange and export, considering the extent to which East European experts or development workers simply tried to impose their sense of a generic socialist model on other countries. One panel, for example, took up the topic of East European contributions to development economics and economic transformations in the developing world. Another considered the dynamic between industrial and cultural exchange by looking at the work of East European architects in Africa and elsewhere, while a third examined imaginaries of race and revolution via international interactions between Hungary and Cuba or the GDR and Africa. The only problem with this thoughtprovoking conference was the complete absence of Czechoslovakia on a program that did include research on Bulgaria,

Poland, East Germany, Hungary, Yugoslavia and the USSR! There are many ways in which scholars of the Czech lands and Slovakia can contribute to this growing interest on Eastern Europe's relationship to the Global South and to projects on global interactions more generally. Perhaps some enterprising CSA member will be inspired to take up this challenge.

Boren Awards provide unique funding opportunities for U.S. undergraduate and graduate students to study in Africa, Asia, Central and Eastern Europe, Eurasia, Latin America, and the Middle East, where they can add important international and language components to their educations.

Boren Scholars and Fellows represent a variety of academic backgrounds, but all are interested in studying less commonly taught languages, including but not limited to Arabic, Chinese, Korean, Portuguese, Russian, and Swahili. As part of the African Languages Initiative, Boren Award applicants have the opportunity to further their study of Akan/Twi, French, Portuguese, Swahili, Wolof, or Zulu. For a complete list of languages, visit our website.

Undergraduate students can receive up to \$20,000 for an academic year's study abroad and graduate students up to \$30,000 for language study and international research. In exchange for funding, recipients commit to working in the federal government for a minimum of one year.

As I look forward to completing my fifth consecutive class for credit in the Czech Language at UNL, I would like to prepare a paper for the SVU World Congress 2015 in North America, based upon archival materials which I have discovered in the Dept. of Archives and Special Collections of the Love Library of University of Nebraska in Lincoln. I am interested in sermons and other memorabilia by John Pastorak (1894-1979), a Roman Catholic priest who came to the United States with his mother from Slovakia in 1897, at the age of three. From 1935 until his retirement in 1973, Father Pastorak preached many sermons, some in Slovak, most of them in English. The majority are typed, with handwritten notes in the margins, the date when he first preached them, and the dates when he "recycled" them. In this sermon, he talks about such topics as the Roman Catholic Church in Mexico, persecution of the Jews throughout history, prohibition in the United States and general themes like love, joy, sin, death, poverty, and hypocrisy. Often he used contemporary news to illuminate his text and even attached newspaper clippings to the sermons. Among the more unusual topics are sermons on Pontius Pilate's wife Claudia (from 1970).
