


Czechoslovak Studies Association General Meeting in San Francisco

The annual meeting of the Czechoslovak Studies Association will take place, following our usual practice, at the ASEEES convention. This year it will be held in San Francisco, and the conference hotel is the Marriott Marquis downtown. Our meeting takes place on Sunday, November 24 from 6:45 to 8:15 pm on the Lower B2 level in Salon 3 (see map below).

The minutes of last year's meeting are printed in this edition of the newsletter, along with the financial statement. Hard copies will be available at the meeting. The agenda will be distributed at the meetings, but as you are all aware from CSA President Kimberly Zarecor's message to the membership earlier this fall, we are facing a number of important issues and urge all CSA members present in San Francisco to make every effort to attend the meeting and provide their input. We will be discussing maters that will have a strong impact on the future of the association.

On happier notes, we will also be announcing the results of this year's CSA Book Prize competition, the results of the election of officers for the next term (this was already distributed by email as well), and recognizing some significant retirements.





A Message from the Outgoing President

As some of you know, CSA is at a crossroads. Our longtime Secretary-Treasurer Dr. Gregory Ference has resigned his position effective this fall. Greg has served CSA in this capacity for 27 years! In this time, he managed all of the finances, membership information, elections, by-laws, and helped with the annual meeting. As President for the last three years, I have relied on Greg for most of the work that needs to be done. I think previous board members would say the same. We all owe Greg a huge thank you and I hope that some of you will reach out to him to acknowledge all done: **GXFERENCE** he has that @salisbury.edu.

We also had another longtime contributor, Dr. Jim Peterson, step down after retiring a few years ago. Jim managed the newsletter for decades. Since 2016, the newsletter has gone out sporadically, an effort led by Hugh Agnew, but he has not been able to get one out recently or to people who want them in the mail. The CSA website is also not live for the moment. This is a longstanding problem as I have been in charge of this for 8+ years and I've only been able to do the most minimal updates for the last few years. This needs urgent attention.

Items for the near term:

1. Transition to an electronic system to collect dues and hold elections (options include Google Forms, PayPal, SurveyMonkey, and Wufoo).

 Divide the Secretary-Treasurer work into two positions and/or assign some work to existing board positions.
Recruit a CSA member to become Treasurer and transition the CSA bank account ASAP.

4. Recruit CSA members to work on a website (we have some funds set aside for this) and a newsletter/new communication format.

5. Update or end the CSA listserv.

3. Fundraising for our prizes - we discussed a proposal at the last CSA annual meeting to do some **fundraising to shore up our prize accounts**. We need someone to help us lead this effort.

Slovo, the journal of the National Czech & Slovak Museum & Library in Cedar Rapids, Iowa is soliciting contributions for its upcoming issue on art and

activism. Summaries written for this audience from previously published work will be considered. This message is from David Muhlena, the Library Director at NCSML.

The overarching theme for our upcoming issue of Slovo is the Czech and Slovak artistic and political response to oppression from without and from from within, starting the midnineteenth century through the current day. We are interested to receive contributions from scholars of Czech and Slovak studies. This issue is somewhat tied to an upcoming exhibit, Artists as Activists. Note that "artistic" is not just the visual arts but also the creative arts (including language. literature, theater, poetry, music); and political is not strictly politics but those long-term efforts to advance the freedom and identity of all Czechs and Slovaks. Those themes are compelling but a little fuzzy, so we are open to suggestions for possible topics. Word length can be between 1,000-1,500 words, depending upon the topic. And we are fine with repurposing content that has already been produced.

Note: *Slovo* is received by the NCSML's members; the writing style is similar to what you find in Smithsonian Magazine, so less academic but still rigorous. Deadline would be after Thanksgiving (still working on a drop dead date). Let me know if you have questions or need clarifications.

Call for Papers: University College of London, School of Slavonic and East European Studies (SSEES) Biennial Postgraduate Conference

What is truth? This question has been proposed by humanity since biblical times. Our conference will focus on the concepts of truth, reality, perception and imagination across the post-Socialist communities of Russia, Eastern and Central Europe.

There are many examples from the region showing how truth is malleable, ranging from official propaganda to interpersonal discourse. The dissolution of the Soviet Union and the transition to capitalism challenged perceptions of reality. Consequently, we see that interpretations of the past and understanding of the present in postsocialist societies are in a state of flux.

We are looking to bring together earlycareer scholars from across academic disciplines, including but not limited to politics, international relations. economics, history, sociology, social anthropology and inter-disciplinary fields in order to spur discussion across disciplines on issues of reality and imagination in the (re)construction of past and present in Eastern and Central Europe. We therefore welcome paper and panel discussion proposals linked to the broad themes of truth, reality and imagination.

Paper and panel discussion proposals could address, but are not limited to, the following questions:

- How are social identities constructed in Central and Eastern Europe?
- What are popular ideas of the true/false dichotomy?
- How is history re-addressed in post-Communist East European societies?
- What are East European Imagined Communities?
- How do East European societies perceive Self and Other?
- How does current news and social media challenge our understating of truth?

We hope that this conference will provide an opportunity for postgraduate students and early career researchers to present their research to a broad, crossdisciplinary audience, as well as to network with other scholars of the Central and Eastern Europe and the Former Soviet countries.

Call for Papers: Twentieth Annual Czech and Slovak Studies Workshop

> University of Pittsburgh March 19-21, 2020

Annual Czech and The Twentieth Slovak Studies Workshop will be held at the University of Pittsburgh on March 19-21, 2020. The program committee welcomes proposals for papers on Czech and Slovak topics, broadly defined, in all disciplines. In the past, the areas of interest have been: anthropology, architecture, art, economics, education, film, geography, history, Jewish studies, linguistics, literature, music, philosophy, politics, religion, society, sociology, and theater.

The Czech and Slovak Studies Workshop aims to bring together researches, scientists, faculty members and advanced graduate students to exchange their experiences, research results, and ideas. New work in progress is appropriate for our workshop format. Each speaker is typically allotted a 50divided between minute slot а presentation and active discussion.

This year's keynote speaker will be Demeš, internationally Pavol an recognized NGO leader who opened German Marshall Fund (GMF) of the United States office in Bratislava, Slovak Republic, in 2000 in order to oversee GMF's activities in Central and Eastern Europe. Before joining GMF, Demeš was executive director of the Slovak Academic Information Agency -Service Center for the Third Sector, a Slovak NGO committed to enhancing civil society. Previously, he served his country as foreign policy advisor to the president of the Slovak Republic (1993-1997), minister of international relations (1991-1992), and director of the Department of Foreign Relations in the Ministry of Education (1990-1991).

The workshop is a collaboration of the University of Pittsburgh, the Czechoslovak Studies Association, and the Slovak Studies Association.

Some funding for Ph.D. candidates traveling from universities in the United States and Canada may be available. Faculty accepted to present at the workshop are encouraged to cover their airfare from their own travel and research budgets.

The deadline for submitting proposals is December 20, 2019.

Submissions should include:

- Name, institutional affiliation and contact details of each author (full mailing address, email address, daytime telephone)
- Curriculum Vitae
- Statement indicating in which years the applicant has previously submitted proposals to and/or participated in the Czech and Slovak Studies Workshop
- Presentation title
- Keywords
- An abstract of approximately 250 words, outlining the presentation






Czechoslovak Studies Association Book Prize Announcement



Stanley B. Winters Distinguished Service Recognition 2019

Gregory C. Ference

The Czechoslovak Studies Association is proud to award the Stanley B. Winters Distinguished Service Award to Gregory C. Ference, Professor of History at Salisbury University in Salisbury, Maryland. He has served with distinction as Secretary-Treasurer of the Czechoslovak Studies Association for 27 years. In that capacity, he has written up detailed notes on each annual meeting of the CSA at the ASEEES meetings. In so doing, he has created an interesting living history of the discussions and issues that have preoccupied the He has also done a meetings. commendable job of managing the finances of the Association and has ensured that its expenditures have served its purposes and projects well.

He teaches courses on European history with a special focus on the Habsburg period, World War I, and Central Europe. He published a book entitled Sixteen Months of Indecision: Slovak American Viewpoints toward Compatriots and the Homeland from 1914 to 1915 as Viewed by the Slovak Language Press in Pennsylvania, with Susquehanna University Press (Selinsgrove) and with Associated University Presses (London) in 1995. In 1996 he authored Chronology of Twentieth-Century Eastern European History (Gale, 1996). There were two publications in 2006. He was co-author of Books, Bibliographies, and Pugs: A *Festschrift* Honor Murlin to

Croucher (Slavica, 2006). In addition, he edited and co-authored an important Portraval book entitled The of Czechoslovakia in the American Print Media 1938-1989, an East European Monograph with Columbia University Press. He put together an author team that included Owen V. Johnson, A. Paul Kubricht, James W. Peterson, and Gregory C. Ference. The book covered the 1938 Munich Crisis, the 1948 Communist Rise to Power, the 1968 Prague Spring, and the 1989 Anti-Communist Revolution.

His service to the CSA has been remarkable, consistent, attentive to details, and greatly beneficial to the organization for a long time. He has taken a personal approach to his responsibilities that has enhanced the fellowship within the organization, as it pulls together the work of so many scholars who center their professional studies on the Czech Republic and Slovakia.

Minutes of the Czechoslovak Studies Association Boston Marriott Copley Place Saturday, December 8, 2018

Lacking a quorum, the meeting began following a waiting period in accordance with the CSA Bylaws. President Kimberly Zarecor called the meeting to order at 5:40 PM with approximately 30 people in attendance. She welcomed all and after a brief discussion of the 2017 minutes from the last meeting in Chicago, called for its approval; those in attendance did so unanimously without any changes.

Secretary-Treasurer Gregory Ference gave his report with a handout noting the financial state of the CSA. (See elsewhere in the *Newsletter* for a copy.) Ference noted the Operating Fund (which includes the book prize monies since there are not enough funds to warrant a separate account) and Pech Prize Fund accounts continue at healthy levels. However, he noted that both prizes have not been self-sustaining recently: this past year, three members contributed \$40 to the Pech Prize Fund, while three gave \$65 to the Book Prize. Membership stands at 122 including 17 new or rejoining members and 6 institutional members. 91 have paid their 2018 dues while 6 members were dropped from the roles since they failed to pay dues for two consecutive years, while one member passed away. Ference noted that changes to the Book Prize bylaws passed with 32 yeses and three nos. The Book Prize will now be in line with the Pech Prize with awarding only the going to

Since no one from the Pech Prize Committee was able to attend, President Zarecor read the committees report with the 2016-2017 prize going to Jakub Beneš for "The Green Cadres and the Collapse of Austria-Hungary in 1918," *Past and Present*, Volume 236, Issue 1 August 2017, Pages 207-241.

Under **Announcements**, President Zarecor talked about the Czech Studies Workshop. It will be held in April 2019, at the University of Texas at Austin. It is co-sponsored by the Slovak Studies Association and the CSA.

Jindřich Toman talked about a new book edited and translated by Vice President David Cooper: *The Queen's Court and Green Mountain Manuscripts With Other Forgeries of the Czech Revival* (Ann Arbor: Michigan Slavic Publications, 2018).

Zarecor then asked the audience for notable achievements, events, and publications with a number of members citing their accomplishments.

In **New Business**, Zarecor asked for volunteers to serve on the Book Prize Committee. Karla Huebner, Frank Henschel, and Karen Uslin agreed to serve.


A lengthy discussion ensued over the possibility of naming the Book Prize. President Zarecor was approached by a member who offered to give a sum of money to the prize with the stipulation that it be named after the member and also the late Czech scholar Jan Havranek. It was noted that an earlier attempt to name the fund after Havranek failed in a vote of the membership. Also in the past, the membership voted to name the article prize after the death of Stanley member Pech and the achievement award after Stanley Winters for their contributions to the organization. The possibility was raised to name the prize after a historical figure like Comenius or Dobrovsky. The mood

of the meeting felt that donations should be accepted with no strings attached. A straw poll was taken whether to name the prize with no definite majority. Zarecor would bring the issue to the board for further discussion.

Under **Discussion Points**, Zarecor stated that there was no progress on the organization's website and that there has been minimal updating. Lastly, President Zarecor noted that there appeared to be no need any longer for a program committee. If anyone requires help forming a panel, contact her.

With business concluded, the meeting adjourned at 6:43 PM.
